**Pool / spa needs draining due to:** (Circle all that apply)

- Bacteria or algae infestation
- Acid Wash
- Chlorine Wash
- Reduce mineral over saturation (high CY, Calcium Hardness, TDS..... etc.)
- Tile cleaning (glass bead)

**Draining:** It is perfectly safe to leave the submersible pump plugged in overnight. It will shut itself off when the pool is empty. Draining a swimming pool will put stress on the interior surface. When you remove the water from a pool, you run the risk of exacerbating certain underlying and existing conditions that are not visible when the pool is full of water. Pinholes, calcium nodules, blisters, air pockets and crazing (hairline cracking) are not visible at the surface of the pool. However, anytime a pool is drained you run the risk of popping, chipping, blistering, peeling or cracking of the pool surface due to pre-existing conditions that reveal themselves when the static pressure of the weight of the water is removed from the pool. These conditions may not become apparent after draining, or even refilling. They can show up in a few weeks or months after re-filling the pool. When these issues become exposed, it is an indicator that the surface is wearing thin or defective and it is time to re-surface your pool.

## I elect to have my pool acid washed

Acid washing is a procedure that utilizes one part water to one part acid solution, which actually removes a small layer of the pools interior surface. Because acid washing removes part of the surface as well as the staining, it may remove a higher percentage of stains along with mineral build-up. Acid washing causes deterioration to the surface and shortens the life expectancy of your pool surface. Please check with your pool builder or your surface manufacture before acid washing.

**NOTE:** Acid wash does not remove the scale from the tile around the water line. The ring on your tile can be removed for an extra charge. This is a separate process that **Pool Kings** can perform. (This process is known as glass bead)

- ★ **Pool Kings** will set a submersible pump in your pool to drain it into your house's plumbing clean outs. (Check on Pool Kings website for where to drain your pool.) We will turn off the power and the auto water leveler to the pool. Pool Kings will check the flow for a few minutes to make sure there are no problems with our pump. Pool Kings is not responsible for the drain clean-out overflowing or any flooding as a result of the draining process. It is the customers responsibility to locate the sewer clean outs on the property. Pool Kings may charge a trip charge if we can not locate the clean outs. Customer Initials \_\_\_\_\_
- ★ **PLEASE DO NOT** turn on the pool light until the pool is filled again. (it can explode) Please make sure to keep your pool pump turned off. Customer Initials \_\_\_\_\_
- ★ **PLEASE DO NOT** allow children or others near the pool until it is again full of water.
- ★ **Pool Kings** will return the following day to add start up chemicals, pick up our submersible pump and start filling the pool. (Unless otherwise instructed) Customer Initials \_\_\_\_\_
- ★ **It is the homeowner's responsibility** to turn off the hose filling the pool and turn the pool equipment power back on. You can call us when the pool is full again. If requested, we will return to balance the water chemistry at that time. Re-balancing your pool water chemistry is an additional charge. Customer Initials \_\_\_\_\_
